
August Highlights

Texas Historical August Events

August 8, 1812 – The Gutierrez-Magee Expedition with about 130 men, crossed the Sabine River from Louisiana in a rebel movement against Spanish rule in Texas.

August 11, 1840 – The Battle of Plum Creek, near present-day Lockhart, ended the boldest and most penetrating Comanche challenge to the Texas Republic.

Birthday - American frontiersman Davy Crockett (August 17, 1786) was born in Hawkins County, Tennessee. He was a farmer, scout and politician who perished at age 49 during the final heroic defense of the Alamo in Texas.





Christopher Columbus set sail from the port of Palos in southern Spain on three vessels on **August 3**, **1492:** la Santa Clara (Niña), la Pinta and la Santa Gallega (Santa Maria). The Niña and Pinta were tiny by today's standards, only 50 to 70 feet from bow to stern, but prized for their speed and maneuverability¹. Columbus was in command of three ships: the Pinta, the Niña, and the Santa María.

National Historical August Events

August 6-10, 1787 - The Great Debate occurred during the Constitutional Convention. Outcomes included the establishment of a four-year term of office for the President, granting Congress the right to regulate foreign trade and interstate commerce, and the appointment of a committee to prepare a final draft of the Constitution.

August 14, 1935 - President Roosevelt signed the Social Security Act establishing the system which guarantees pensions to those who retire at age 65. The Social Security system also aids states in providing financial aid to dependent children, the blind and others, as well as administering a system of unemployment insurance.

Community Events

I want to personally thank Larry Stamps for a solution to an issue that has concerned me for some time. The air conditioner condensation drain was pouring onto the sidewalk and causing algae to grow, discolor the walkway and just stay wet. I cleaned the area several times and bleached it to kill the algae and remove the stain. First time I did it I slipped on the algae and almost fell. I knew we had to find a way to prevent this potential hazard.

Larry stated the possibility to redirect the drain line to a sewer vent in the attic. Tim Sheets, myself and Larry Garcia went into the attic to check what it would take to implement this solution. Larry Garcia looked around and found that the drain line from the AC was above of another line going to a vent pipe. I met with Larry on Saturday morning and he attached the two lines and just like that problem solved. Thanks to Larry Stamps and Larry Garcia.

With election season approaching here is a reminder of our CC&Rs regulation on Political Signs.

Article II, Section 16, paragraph A

Political signs are permissible on Improved Lots only and must be in accordance with Texas Property code, Section 202.009.

Texas Property Code § 202.009 Regulation Of Display Of Political Signs

Sec. 202.009. REGULATION OF DISPLAY OF POLITICAL SIGNS. (a) Except as otherwise provided by this section, a property owners' association may not enforce or adopt a restrictive covenant that prohibits a property owner from displaying on the owner's property one or more signs advertising a political candidate or ballot item for an election:

- (1) on or after the 90th day before the date of the election to which the sign relates; or
 - (2)before the 10th day after that election date.

Please do not post any signs that contain language, graphics, or any display that would be offensive to the ordinary person.

The City of Kerrville has adopted new animal enforcement ordinance that went into effect this April. The entire 23 page ordinance is available on https://vicksburgvillage.net
The following is the excerpt that would most apply to the Village.

Sec. 18-31. Nuisances.

- (a) All dogs and cats, excluding community cats, shall be kept under restraint.
- (b) No dog or cat may be allowed to cause a nuisance. The owner of every dog or cat shall be held responsible for every behavior of such dog or cat under the provisions of this article.
- (c) A dog or cat is considered a nuisance if it damages, soils, defiles, or defecates on private property other than the owner's or on public walks and recreation areas unless such waste is immediately removed and properly disposed of by the owner; causes unsanitary, dangerous, or offensive conditions; causes a disturbance by excessive barking or other noisemaking; chases vehicles; or molests, attacks, or interferes with persons or other domestic animals on public property.

[As defined in the definition part of this ordinance: Community cat caregiver means a person who participates in trap-neuter-return.]

- (d) It is unlawful for a person to feed feral cats or to provide food for feral cats. It is an affirmative defense if the person is a community cat caregiver maintaining a community cat colony.
- (e) If a community cat colony is the source for a substantial number of nuisance complaints from multiple sources, the affirmative defense under subsection (d) does not apply and the community cat colony must be relocated or the cats claimed by owners and re-homed. A substantial number of nuisance complaints means three or more complaints within the past 12 months. Multiple sources means that there are two or more reporting parties that do not reside at the same address.

Sec. 18-32. Community cats.

- (a) Community cats impounded on a nuisance complaint shall be humanely euthanized after expiration of the redemption period unless a community cat caregiver claims the community cat and agrees and is able to relocate the cat t another location, in compliance with this chapter. Community cats may be held longer, as space is available in the animal shelter.
- (b) Community cats that bite or scratch a person shall undergo rabies observation or testing, shall be euthanized in accordance with law, and may not be released, including to a community cat caregiver.

Sec. 18-33. Redemption.

- (a) A community cat released to a community cat caregiver may be released without payment of an impoundment fee, unless the community cat was seized pursuant to a nuisance complaint.
- (b) Any dog or cat confined for rabies quarantine, evidence, or other purpose may be redeemed by the owner thereof upon payment of a fee. Disposal of a dog or cat by any method specified herein does not relieve the owner of liability for violations and accrued charges.
- (C) No dog or cat required to be registered or vaccinated under this chapter may be redeemed until arrangements for such registration and vaccination have been made.
- (d) As a condition for redemption, the animal control authority may require a dog or cat, including community cats, to be microchipped and have the microchip registered such that the animal control authority is avle to identify the owner or community cat caregiver, as applicable.

The CCR's Committee is progressing toward its goal of completing both thereview of the Vicksburg Village Homeowners Declaration of Covenants, Conditions, and Restrictions and the Bylaws in August of 2024, and presenting its Fourteenth Amendment recommendations to the Vicksburg Village Board of Directors for its review and suggestions before seeking legal counsel and presenting to the Owners for approval in January 2025.

Our Vicksburg Village rules state, "A homeowner is responsible to keep their trees trimmed so that there are no limbs or branches less than 10 (ten) feet above a sidewalk or less than 14 (fourteen) feet above a street."

We have many trees here which do need to be trimmed. Is yours one of them?

There are only two 'common areas' within the Village whose trees will be trimmed and paid for by the Village. One is the Clubhouse area and the other is the block of properties surrounded clockwise by Florian Dr, Vicksburg Ave, DeGrasse Dr, Yorktown Blvd, and the lower part of Fitch St.


